## 2018 Elections to Council

The CMRTO will hold elections in Districts 2 and 5 on April 4, 2018. Members who are eligible to vote in these districts will be sent an email on November 30, 2017 detailing the online election process. Nomination forms giving all interested and eligible MRTs the opportunity to stand for election in 2018 will be emailed on December 5, 2018.

District 2 (Eastern District, Radiography) is composed of the District Municipality of Muskoka, the Districts of Parry Sound and Nipissing, the United Counties of Prescott and Russell, Stormont, Dundas and Glengarry, and Leeds and Grenville, the Counties of Frontenac, Hastings, Lanark, Lennox & Addington, Prince Edward and Renfrew, and the City of Ottawa.

## New online quiz for the Legislation Learning Package

As a way of supporting MRTs' learning about the legislation that governs and guides the profession, CMRTO developed the Legislation Learning Package as a part of the CMRTO jurisprudence course. All applicants for registration with the CMRTO are required to have successfully completed a course in jurisprudence approved by the College. The jurisprudence course may also be used by members to maintain and improve their understanding of the legislation and legal requirements which impact upon their day-to-day practice in medical radiation technology.

Since the application of law in a day-to-day practice can be complex, this course has been designed as a review of key components of the appropriate legislation and regulations that govern the practice of medical radiation technologists (MRTs) in Ontario.

As part of our ongoing effort to introduce new online features and services, MRTs can now access the Legislation Learning Package easily from their ePortfolio.

## Update on the regulation of diagnostic medical sonographers

### Registration regulation consultation

The first step in the process of regulating sonographers is amending the CMRTO's registration regulation to enable us to register diagnostic medical sonographers as a fifth specialty and set out the registration requirements for an applicant to be issued a certificate of registration in the new specialty.

The proposed amendments were posted to the Consultations page on the CMRTO website. Although the consultation closed on October 17, 2017, the comments can still be viewed by clicking [here](#). After reviewing all the comments received, Council approved the amended registration regulation at their meeting on October 20, 2017. The amended regulation was submitted to the government on October 24, 2017 for approval by Cabinet.

### Bill 160

At the end of September, the Ontario Government introduced Bill 160, the *Strengthening Quality and Accountability for Patients Act, 2017*, Bill 160, part of which proposes changes to the *Medical Radiation Technology Act* (MRT Act) to strengthen and make more transparent oversight of diagnostic medical sonographers. If passed, the MRT Act would be repealed and replaced with the *Medical Radiation and Imaging Technology Act*.

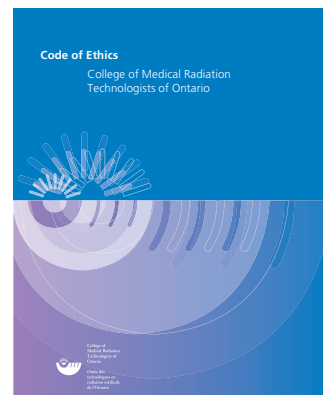
The new *Medical Radiation and Imaging Technology Act* will affect the CMRTO:

- by changing the CMRTO's name to reflect its full membership, including diagnostic medical sonographers, to the College of Medical Radiation and Imaging Technologists of Ontario (CMRITO)
- by changing the current CMRTO scope of practice statement to include the "application of soundwaves" in order to incorporate the practise of diagnostic medical sonographers
- by appropriately identifying all medical radiation and imaging professionals who are members of the (new) CMRITO.
